#### January 15, 2021

As of December 31, 2020, Adobe<sup>®</sup> ended support for Flash Player. Continuing use of Flash Player can adversely affect your experience with UKG<sup>™</sup> products. Adobe<sup>®</sup> strongly recommends that all users immediately uninstall Flash Player.

#### December 15, 2020

Microsoft<sup>®</sup> recently announced plans to end support for Internet Explorer<sup>®</sup> 11. As a result, we want to give you advanced notice that your UKG Pro<sup>™</sup> solution will begin phasing out IE 11 support in April 2021, while UKG HR Service Delivery will conclude support on August 15, 2021.

UKG HR Service Delivery<sup>™</sup> is built using Responsive Design technology which means a specific mobile app is not required and the solution is designed to optimize the user experience while allowing full feature access through mobile devices. The UKG HR Service Delivery<sup>™</sup> application is accessed through a device's browser and the screen resizes based on the mobile device (for example, phone versus tablet).

UKG Pro recommends additional adjustments for Internet Explorer 11.

- 1. Ensure the Compatibility View settings are disabled.
- 2. Enable Downloading in Internet Explorer 11 to ensure that you can download files from the UKG Pro solution.
- 3. Enable Native XMLHTTP Support in Internet Explorer 11 to ensure UKG Pro functions properly:
- 4. Disable User Name and Password Autocompletion in Internet Explorer 11, to enhance security while using the UKG Pro solution with Internet Explorer 11 in kiosk or other public environments.
- Allow Automatic Logoff with Internet Explorer on Windows 10. The automatic logoff issue is caused by the DO NOT TRACK feature in Windows 10 Internet Explorer 11. As a workaround, we recommend to disable the <u>DO NOT TRACK</u> feature, which prevents the logout issues being experienced by users in this configuration.
